MBJG Rules and Behavioral Contract

Morning and Afternoon Transitions:

JGs must take program equipment up/down in a timely manner until all equipment is on/off the beach

JGs cannot be horseplaying

JGs will not hide in the dunes (exception only during Capture the Flag)

JGs will walk only on pathway between the ramp and the box, DO NOT walk through the parking lot during program hours unless directed by parent/guardian or staff

General Daily Rules:

If the staff says to do something, then do it.

Do not throw sand

No wrestling/fighting/table topping/dangerous physical contact with anyone

Do not harass the staff, fellow JGs, the public or marine life

No disrespectful/harmful contact with other JGs or the staff

No cursing

No phone use, unless in emergency or permitted by staff to contact parent/guardian

Do not interrupt the staff:

If you have something to say, raise your hand and wait to be called when instructors are giving activity and safety instructions

Wear the MBJG uniform each session day during program hours

Free Time:

Go to the beach within 3 minutes of when the staff tells you to. Consequence: If you are late, you will start the next free time 10 minutes late.

Stay within the boundaries set by the staff

All General Daily Rules still apply

Disciplinary Action for Rule Breaking: 3 strikes your out!

1st offense = Verbal warning - your instructor will tell you, "this is your verbal warning"

2nd offense = Physical punishment (a supervised run, pushups or time away from activity)

3rd offense = Meet with Beach Instructors and Program Coordinator

4th offense = Sent home for day

If restricted behavior continues parents will be called for JG pickup. Multiple pick ups will result in expulsion from the program.

If it is consistent, you are done with the program
